LEASE AGREEMENT

This LEASE AGREEMENT ("Agreement") is made on this 17th day of March, 2021 between Neyveli Uttar Pradesh Power Limited, a company incorporated under the Companies Act, 1956 and having its registered office at 6/42, Vipul Khand, Gomti Nagar, Lucknow-226010 (U.P.) {hereinafter referred to as "LESSOR", (which expression shall mean and include, unless repugnant to the context, its successor in business and permitted assigns) represented by SHRI K. Mohan Reddy S/o Bakki Reddy CEO NUPPL R/o Power Plant Site Office Lahurimau Post Samuhi, Ghatampur, Kanpur Nagar, Adhar No: 815744119577, Pan No : AAECN3221F, Mob- 7598845303} of the one part and DAV-NUPPL Public School, NUPPL-Township, Village-Rampur, Tehsil -Ghatampur, District -Kanpur Nagar, Uttar Pradesh {hereinafter referred to as "LESSEE", (which expression shall mean and include its successor in business and permitted assigns) represented by SHRI Anand Swaroop Saraswat S/o Kishan Swaroop Saraswat (Manager DAV NUPPL Public School, NUPPL-Township Rampur, Tehsil -Ghatampur District-Kanpur Nagar U.P.) R/o H.N. 2229, Sarojani Kunj Gail Gaon, Dibiyapur, Vasundhara, Auraiya, Adhar No : 682552630552, Pan No : AGEPS1744H, Mob- 8077192303} of the other part.

LESSOR and LESSEE shall jointly be referred to as "PARTIES" and individually as a "PARTY".

WHEREAS the LESSOR and the LESSEE, as per the covenants of the memorandum of the understanding signed between them on 7th day of October 2020 ("MOU") agree to run a school in the name of DAV NUPPL Public School, NUPPL-Township, Rampur Village, Ghatampur Tehsil, Kanpur Nagar (U.P.), financially subsidised by the LESSOR as a philanthropic venture, and academically managed by the LESSEE on the land and existing building measuring 3387.54 Sq meters situated at Gata No. 1278 (Old Gata No 581 & 583) of Village-Rampur, Tehsil-Ghatampur, District -Kanpur Nagar, Uttar Pradesh ("Property") more particularly described under **Schedule-I** given for temporary occupancy of the aforementioned school at the Property.

Now, it is hereby expressly agreed and declared by and between the parties as follows: -

1. That this Agreement shall be construed as agreement for lease/tenancy and not otherwise creating any right, title or interest of whatsoever nature in the Property in favour of the LESSEE, which is not at all the intension of the parties but on the contrary merely a temporary agreement or arrangement, simply to allow the LESSEE to use the Property for managing the school and for related purpose for which purposes the LESSEE shall retain the building. The LESSOR may have his own staff in the said plot for the care, supervision, maintenance of and services to the Property.
2. That the LESSEE shall, in consideration of such accommodation as hereunder provided, pay to the LESSOR a nominal licence fee of Rs. 1/- (Rupees one only) per annum as charges for such temporary occupation, which sum will be paid on the first week of April of every financial year without delay and default.
3. This Agreement shall (unless terminated earlier) be valid, binding and in force for a period of 29 (Twenty-Nine) years with effect from 17th day of March 2021 ("Term").
4. Notwithstanding anything contained herein before, the LESSOR or the LESSEE expressly agree that in case either party wish to terminate the MOU in accordance with Para no. 7 and 8 therein, this Agreement shall automatically stand terminated with the MOU.

Provided, however, and notwithstanding anything hereinbefore contained, it is hereby expressly agreed by and between the parties hereto that in the event of breach

of any terms and conditions of this Agreement and the failure of LESSEE to rectify such breach within a period of 30 (thirty) days from the date of issuance of notice by the LESSOR, or default of any payment, the LESSOR shall be entitled to and shall have always the power to revoke the licence hereunder granted at its absolute discretion and to reoccupy the said portion of the Property on a notice of two academic sessions – the current and the following, without subjecting himself to any liability on that account and notwithstanding any intermediate and negotiation or waiver off breach thereof and in such an event the LESSEE shall surrender the occupied portion of the property as here under contemplated.

5. The LESSEE shall not have any right to make any addition or alteration to the Property except for removal of wooden partition by way of adjustments but shall be entitled to make interior decorations only by temporary wooden partitions which they shall remove at their own costs and expense at the time of surrender of the Property upon expiry of the term or earlier termination of this Agreement. The LESSEE agrees to return the Property to the LESSOR in the same condition as received (excepting normal wear and tear) and repair all the damages, if any, to the Property at its own costs and expenses.
6. This agreement shall come in operation only after the notice of commencement is given by the LESSEE to the LESSOR in writing.



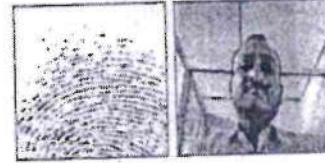

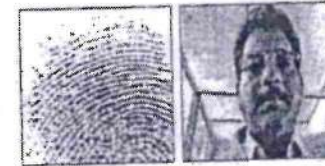
