

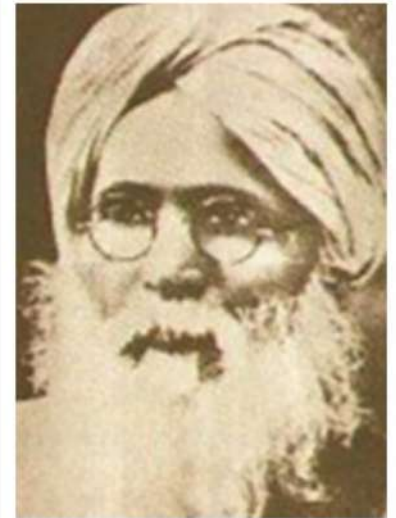
History



Centuries of domination had degenerated the once great Indian society and culture into an abyss of ignorance, sloth and inertia by the time Swami Dayanand Saraswati (1824-1883) arrived to regenerate and reconstruct. The whole of India was suffering from a cultural crisis. People had drifted from their cultural moorings and were lost in a no man's land—neither here nor there. The rich Indian culture and heritage had lost its luster and aping the West blindly had become a fashion statement; it carried prestige and position in society. Swami Dayanand Saraswati realised that the once lively and pulsating Indian society had gone into deep slumber and that the pressing need of the hour was to wake it up, to reactivate and rejuvenate it. Possessed of sharp intellect and a vision far ahead of his times, he realised that the salvation lay in educating our people by propagating the real message of the Vedas. He knew that not just knowledge but wisdom and reason can distinguish man from an animal. He ceaselessly worked to induct a new life in his people through religious reformation, social reconstruction, cultural regeneration and political emancipation. He urged people to shun dogmas and adopt scientific outlook. He led them towards a new kind

of awakening – based on wisdom, reason, and science. He was the first Indian who realized the importance of education for the well-being of society.

The philosophy of Swami Dayanand Saraswati was translated into reality by Lala Hans Raj, later known as Mahatma Hansraj (1864-1938) and his selfless and dedicated associates, the founding fathers of the D.A.V. Movement. Frail of body but possessing heroic spirits, Mahatma Hans Raj voluntarily opted for a life of self denial and renunciation. He started a school in Lahore on 1 June 1886 and devoted his whole life to this school. He named the school as D.A.V. School, that is Dayanand Anglo-Vedic School. The movement spread gradually and with the passage of time a large number of D.A.V. Institutions came into existence. But the partition of the country in 1947 left more than half the D.A.V. Institutions in Pakistan. Rehabilitation of the institutions and displaced employees and students was a herculean task but the challenge was met effectively by the stalwarts of the D.A.V. Movement like Lala Lajpat Rai, Bhai Parmanand, Lala Dwarka Das, Principal Sen Das, Bakshi Ram Ratan and Bakshi Tek Chand. They were the ones who put life back into it and rehabilitated the organisation.



Mission

The D.A.V. vision of education is in keeping with the National Policy on Education (1986) and in accordance with New Education Policy. It lays great emphasis on developing a national system of education with Education for all; eliminating disparities in educational system, providing more facilities through qualitative intervention, empowering women, providing education to disadvantaged sections of the society. - ❖ To provide a wide range of holistic education by homogenizing the western knowledge while remaining anchored to the Indian cultural moorings;

- ❖ To sensitize individuals towards social welfare.
- ❖ To nurture creative and resourceful minds who think big, think fast and think ahead, who care for the nation and the weaker sections of society and are imbued with humanistic passions and values.

About DAV NUPPL Public School

DAV NUPPL Public School - a Co-educational English Medium Public School - has been established on November 9, 2020 in collaboration by DAV College Trust and Management Society, New Delhi and Neyveli Uttar Pradesh Power Limited in Ghatampur, Kanpur Nagar, Uttar Pradesh.

The school is located in the NUPPL Township to cater to the educational needs of the wards of the workforce employed in the service of NUPPL. As a part of its social responsibility, the school keeps its doors open for the learners from the locality surrounding the plant.

Its journey starts by lighting the path of its students of classes Nursery to VII leading to class XII on Public School lines in a phased

manner. It is resolved to ensure quality education by laying emphasis on both academics and co-curricular activities through a highly qualified and skilled work force and state-of-the-art infrastructure. The core purpose is to provide high-quality education by nurturing all the five aspects of education-Physical, Mental, Emotional, Social and Spiritual well-being.

The school building comprises 14 classrooms, Science Lab, Computer Lab, Maths Lab, Library Hall, Craft Room, Music & Dance Room, Multi-Purpose Room, Principal's Room, Staff Room, Office Hall, Examination Room, Store Room, Sports Room, and Medical Room. All classrooms are proposed to be smart classrooms facilitating learning through audio-visual aids. The playground offers ample space to the students to practice different sports and games. Facility of an auditorium has been provided to organize school programmes and functions. The school campus will be guarded by CCTV surveillance to ensure safety of the students. Female attendants are to be appointed for students' security inside the school premises. Ramps have been constructed considering the specially-abled children who may take admission in the school. Play area with swings for the Kindergarten students, provision of RO Drinking, separate toilets for girls and boys and 3 sets of staircases are the other highlights.

The school is all set to soar high to realize its vision to impart education that makes its students human beings in the true sense of the word - self-reliant, contented, fearless and compassionate.

Admission Procedure

Registration procedure and rules

- Registration forms are to be filled in and submitted to the school office before the end of the registration period.
- Incomplete or illegible registration forms, without photographs, will not be processed/accepted.
- Dates for test/interview/interaction will be given at the time of registration
- The school authorities reserves the right to change the date and time of test/Interview/interaction
- Mere issue of registration form does not imply admission which is subject to admission test/interviews/interaction and to the availability of seats
- Photocopy of birth certificate issued by municipal corporation or concerned civic authority along with a photocopy of aadhar(child and both parents) must accompany admission/registration form. An affidavit or any other evidence is not acceptable in support of birth certificate. TC from recognized school duly signed by principal and photocopy of report card of last exam passed must be attached with registration form for class I and above.

Entrance Test/Interviews/Interaction:

- There will be written test for students seeking admission to classes I and onwards. However, for lower classes admission will be based on personal interview of the child along with the parents on the date given.
- Result will be displayed on school notice board/Website as soon as possible
- Age criteria for admission in session 2023-24 as per school norms.

Admission formalities

- Successful candidates, Whose names are included in the merit list must pay the admission and other fee by the date specified by the school.
- Parents are requested to submit the transport form(where applicable)along with filled admission form at the time of payment of fees.

Non-refund of fees

- The fees once paid is not refundable for any reason whatsoever.

Rules and Regulation

GENERAL REGULATIONS

1. Bringing of mobile phones in the school premises is strictly prohibited. Jewellery, cash and costly items are not allowed to be brought in school by the students.
2. Any kind of damage done to school property by any student is a punishable offence and it is to be compensated by him or her.
3. Disobedience or any misconduct affecting the discipline of the school is dealt with seriously.
4. All students are expected to reach school before the school bell rings.
5. A Disciplinary action will be taken if the children are repeatedly coming late to school. Parents' co- operation is solicited in maintaining punctuality, regularity and discipline.
6. Lending or borrowing of money or any other articles is strictly prohibited.
7. Students should observe polite behavior .Shouting bullying or use of foul language is forbidden.
8. Every student is expected to maintain an attendance record of at least 75% during the academic year, failing which he or she may not be allowed to take the examination.
9. The identity card must be worn by the students everyday.
10. Special fine will be imposed for being absent without prior permission on special occasions or during the period important from learning point of view.

LIBRARY RULES

- ❖ Library facility is available to all the students according to class time table.
- ❖ A book shall be issued for a maximum period of seven days. After that a fine of Rs. 10/- per day per book shall be charged.
- ❖ Reference books cannot be issued.
- ❖ In case of loss or damage of a book, the borrower shall have to either replace the book or pay double the price of the book.
- ❖ No school bag/carry bags/ eatable items are allowed in the library.
- ❖ Wearing ID card is mandatory and no book will be issued without ID card.
- ❖ Students are advised not to get book issued to their friends on their ID Cards.
- ❖ Any kind of indiscipline in school library will be considered punishable.

IMPORTANT INSTRUCTIONS REGARDING FEE DEPOSITION

1. Parents must deposit the Quarter Fees of the Session 2023-24 through the School Website only (<http://davnuppl.in/osm/login>)
2. The School does not accept cash or cheque under any circumstances.
3. To deposit the fee online, one needs to login on to the School website.
4. To login, use Admission Number of your ward as User Id and enter Date of Birth of your ward as Password. (Date of Birth Format – ddmmYYYY – 24012011)
5. The School Fees is to be paid on Quarterly Basis in Four Installments :-
6. The First Installment is to be paid in the first month of Quarter 1 (April – June) i.e., in April.
7. The Second Installment is to be paid in the first month of Quarter 2 (July – September) i.e., in July.
8. The Third Installment is to be paid in the first month of Quarter 3 (October – December) i.e., in October.
9. The Fourth Installment is to be paid in the first month of Quarter 4 (January – March) i.e., in January .
10. Late Fee Charges will be applicable @ Rs 10/- per day in the Second & the Third months of the Quarter.
11. To avoid Late Fee Charges, The fee is to be deposited within the first month of each Quarter only.
12. If a student fails to pay the School Fee for consecutively three months, i.e., within the respective Quarter, his/her name will be struck off and the child will have to be readmitted after clearing the pending dues and readmission charges will be applicable.

Art and Craft Room



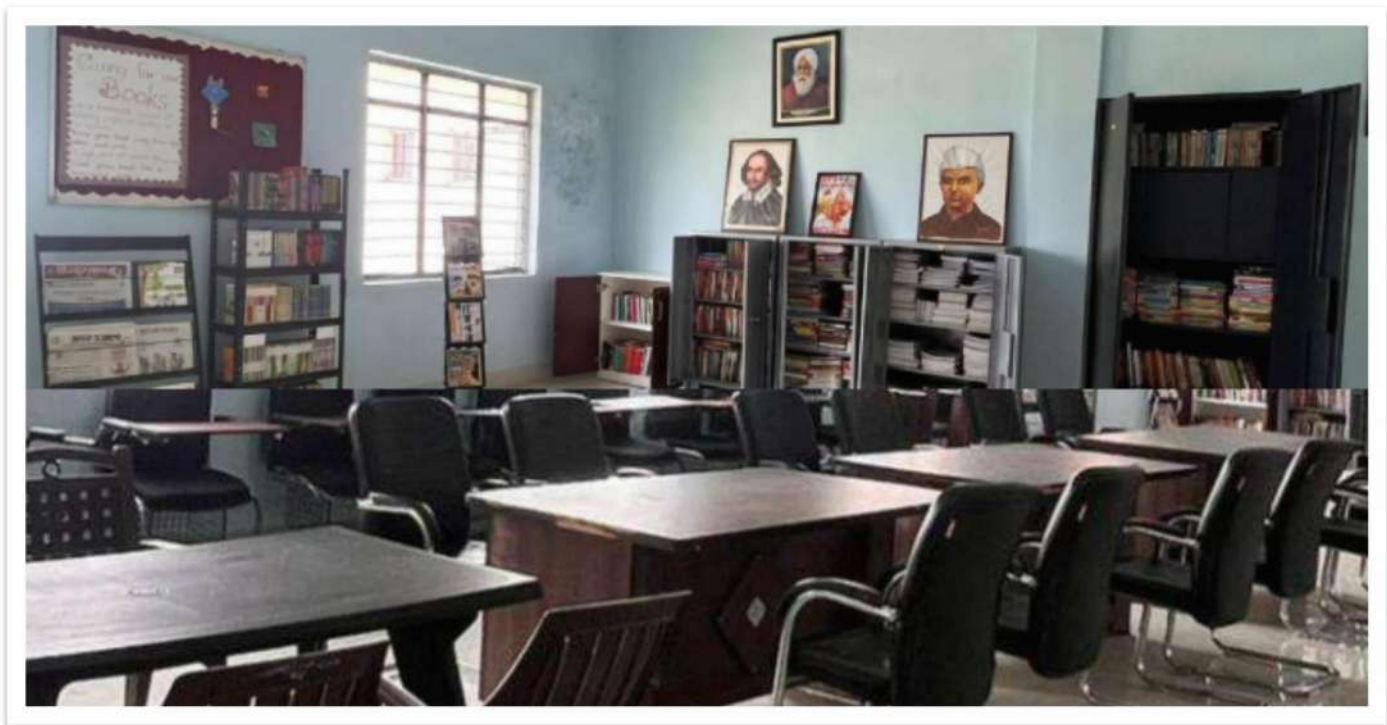
This room is built to nurture the aesthetic sense and creativity in the young minds and also motivate them to create masterpieces using waste material.

Library



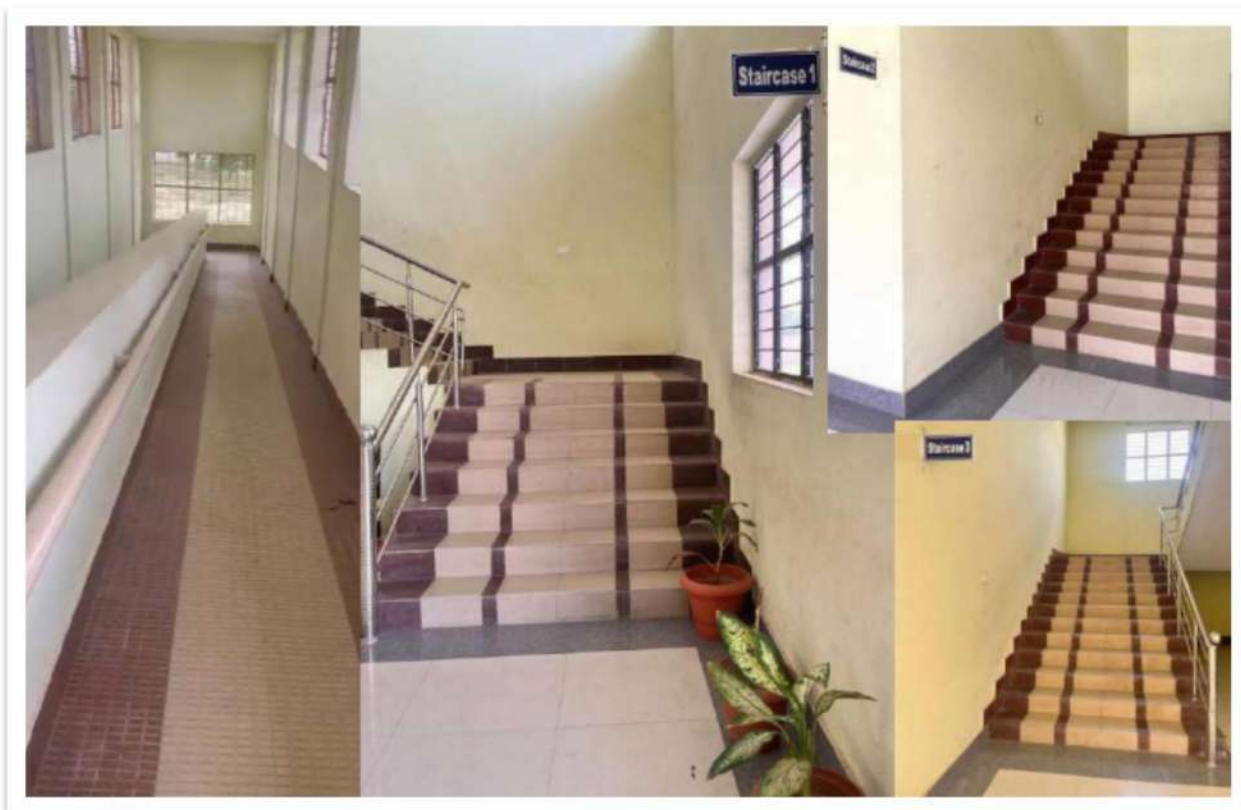
Our library endorses desirable study habits in the students and it also enhances the critical thinking, innovation and curiosity in the students. It is also serves as a capacity building hub for the teachers.
